NHS Education for Scotland (NES) is an education and training body and a national health board within NHS Scotland. We are responsible for developing and delivering healthcare education and training for the NHS, health and social care sector and other public bodies. We have a Scotland-wide role in undergraduate, postgraduate and continuing professional development.

NES Pharmacy provide education for trainee pharmacists, registered pharmacists and pharmacy technicians and the wider pharmacy teams across Scotland. We do this through organisation, development, delivery and quality management of educational programmes and professional development courses and resources.

In addition, we support the national experiential learning of student pharmacists in Scotland in partnership with Robert Gordon University, University of Strathclyde, and other stakeholders.

Training programmes

Pharmacist Programmes

Preparation for Facilitation of Experiential Learning

Scottish pharmacy experiential learning is funded by the Scottish Government and organised in partnership between Robert Gordon University, the University of Strathclyde, NHS Education for Scotland (NES) and other pharmacy stakeholders.

NES Pharmacy supports experiential learning (EL) in Scotland by managing the financial governance of ACTp funding and providing Quality Management of EL, through training of facilitators and premises approval of training sites, on behalf of the universities.

Foundation Training Year

Post-registration Foundation Programme

NES Pharmacy manages the educational infrastructure for Post-Registration Foundation programme for newly qualified pharmacists in Scotland. The programme aims to equip pharmacists who are early in their career with a broad range of general skills and provide them with a foundation on which they can develop further. Since Autumn 2021, the programme has been aligned with the UK-wide Royal Pharmaceutical Society (RPS) Post-Registration Foundation pharmacist curriculum. Prescribing and Clinical Skills

NES Pharmacy supports Pharmacist Independent Prescribers (PIPs) within their training period, in implementation of their training into practice once they have qualified and those who are returning to prescribing practice. We commission places on Pharmacist Independent Prescribing courses run by both Schools of Pharmacy in Scotland each year. Pharmacists who practise in Scotland can also apply to NES Pharmacy for funding to undertake these courses. We provide support through clinical skills courses, teach and treat training hubs (in collaboration with Community Pharmacy Scotland and Health Boards).

Pathway to Advanced Practice for Pharmacists working in GP Practice.

Pathway to Advanced Practice for Pharmacists working in GP practice is a programme for those newly established in primary care, who are wanting to work towards advanced practice. Cohorts start each autumn and include monthly peer-review and simulation opportunities. Interest should be noted through Health Board education and training leads. Pharmacy Technician Programmes

Pharmacy Technician Pre-registration Training Scheme

The introduction of funding in 2022 has allowed NES Pharmacy to develop structures and processes to implement a National Pre-registration Trainee Pharmacy Technician (PTPT) Scheme including the administration of Technical Apprenticeship (TA) funding from Skills Development Scotland, on behalf of NHS Boards.

Vocational Training Foundation Programme for Pharmacy Technicians (VTFPPT)

The Vocational Training Foundation Programme for Pharmacy Technicians has been developed in response to an existing gap in Pharmacy Technician education and development. The Foundation competency framework which underpins the programme has five generic core elements which enable Pharmacy Technicians working in hospital, community and primary care (including cross sector roles) to undertake a standardised foundation training programme. Additional role specific competencies allow the pharmacy technician to undertake development within their own sector allowing them to gain specialised experience. The programme aims to build in a progressive manner a common set of behaviours and skills required by all Pharmacy Technicians. It is designed to increase confidence, competence and capability. Pharmacy Technicians completing the programme will develop a systematic approach to practice within their defined roles. General Practice Learning Pathway (GPLP) for Pharmacy Technicians

NES Pharmacy has developed a Learning Pathway for Pharmacy Technicians working in General Practice. This pathway aims to support the delivery of the Pharmacotherapy service as outlined in the GMS 2018 Contract. The pathway also complements and provides additional guidance for those undertaking the Vocational Training Foundation Programme for Pharmacy Technicians.

Registration with NES is required to access the full Learning Pathway programme. The Learning Pathway programme will be run annually, and frequency will be reviewed in line with demand and resource. NHS Boards will be invited to nominate interested Pharmacy Technicians.

[Environmental Issues in Respiratory Prescribing](#)

As we address many issues to assist NHS Scotland achieve net zero greenhouse gas emissions by 2040, much focus of attention has been turned toward respiratory prescribing. Approximately 3% of the carbon footprint of NHS Scotland results from the use of metered dose inhalers, with salbutamol accounting for two thirds of this. We know that there are lower global warming potential inhalers available, but we also know that there are opportunities to improve respiratory care which also has the potential to reduce the carbon footprint of respiratory prescribing. An overview of recommendations for improving respiratory care and reducing the global warming potential arising from inhaler prescribing will be presented with some practical suggestions for use in practice.

Aims to meet the education and training needs of pharmacists and pharmacy technicians who deliver services to people with a diagnosis of dementia, their families and carers. The pack is organised into six main sections. The first three sections focus on the subtypes of dementia, the risk factors and early signs, the screening and diagnostic processes. Sections 4 and 5 cover living with dementia, from the early stages, throughout the progression to requiring more help and support. The final section focuses on symptoms most often (but not exclusively) associated with the later stages of dementia, end of life care and dying well. There are various activities throughout the pack as well as several case scenarios with a pharmaceutical care plan being developed as the patient journey proceeds.

Depression
